



Who We Are

The School Energy Coalition (SEC) was formed in February 2011 to find school and business pathways funding for school energy and water projects. These pathways, along with technical assistance and training, must be focused on achieving savings and creating maximum system efficiencies on school sites.

SEC ensures that schools have a voice before the Legislature and the State as agencies move forward to implement legislation and regulatory actions. SEC has participated in proceedings related to energy and water before the Public Utilities Commission (CPUC), the Energy Commission (CEC), the Air Resources Board (CARB), the Division of the State Architect (DSA), and the Department of Water Resources.

SEC advocates and informs State agencies on the impacts of energy and water efficiency, conservation, and renewable measures on K-14 schools. We seek to retain program and regulatory flexibility and to open future avenues for State and Federal funding sources and technical assistance.

Our membership consists of school districts, community colleges, and businesses that specialize in energy and water efficiency.

2012-15 SEC Activities

- Successfully advocated on state legislation related to energy efficiency and renewable generation for K-14 schools.
- Communicated support for funding for greater building efficiencies, Net Energy Metering, as well as the impacts of rate changes to school energy investments, and Cap-and-Trade action proceedings to the CPUC and the California Legislature.
- Proposition 39 Guideline changes and budget recommendations to Governor Brown and various state agencies to advocate that schools receive their share of the Proposition 39 funding.
- Participated in stakeholder meetings with the Division of State Architect and hearings before the State Building Standards Commission on Irrigation and Landscaping regulations related to potable water use on school sites that resulted in amendments that were less onerous to school districts.
- SEC provided several regional Forums for our members on the drought emergency and water mandates statewide which included valuable outreach and education of school district issues to water agencies throughout California and vice versa. This outreach has opened the door to future discussions as water bond programs are implemented and funding is made available in the months ahead.

Membership in SEC provides superior access and opportunities for input on state actions related to energy and water issues involving school construction. We provide networking and educational forums for schools and others including key policy-makers, to share up-to-date information about how to successfully move school energy and water projects forward through legislative hearings and workshop sessions.
